Auditions for the Missoula Children's Theatre production of "Sleeping Beauty" will be held June 14, 10:00 a.m. at Village Baptist Church, 101 Matthew Blvd, Destin. Auditions are open to those entering 1<sup>st</sup> through 12<sup>th</sup> grade in the fall. Approximately 60 students will be cast to appear in the show. There is no guarantee that everyone who auditions will be cast in the play. Students wishing to audition must arrive by the scheduled starting time and stay for the entire 2-hour session. The first rehearsal begins approximately 15-30 minutes after the audition. This is a group audition – no advance preparation is necessary, but a smile never hurts. Students should be ready to come and have a good time!

Rehearsals will be conducted everyday from 10:00 a.m. – 2:30 p.m. at Village Baptist Church in the second floor of the church. Not all cast members will be needed at every session, but everyone must have a clear schedule for the entire week and if selected be able to attend all rehearsals required for their role. A detailed rehearsal schedule will be distributed at the conclusion of the audition. Cast members scheduled for the full 4-1/2 hours of rehearsal are asked to bring a sack lunch (no warm food or fast food deliveries allowed) that can be unrefrigerated from 10:00 a.m. to noon.

The performance will be held on June 18 at 6:30 p.m. in the Village Baptist Church sanctuary. The cast will be called for dress rehearsal before the performance that day. All cast members must be available for all scheduled performances. To pre-register, fill out the form below and mail it back with your check for \$65 for each student. Checks will be held until your student is cast.
